Colorado Department of Public Health and Environment Denver (Nov. 16, 2023) -State health officials encourage Coloradans who are pregnant to get a vaccine called Abrysvo to protect their unborn children from RSV, respiratory syncytial virus. MORATORIUM ON NEW ENROLLMENTS FOR NON-EMERGENT MEDICAL TRANSPORATION (NEMT)

The state has imposed a moratorium on new enrollments for Non-Emergent Medical Transportation (NEMT) due to a significant potential for fraud, waste, or abuse to the Medicaid program. The moratorium will be in place for a minimum of 6 months and may extend beyond that. Additional information will be announced as it becomes available. NEW PROVIDER TYPES 2024: MARRIAGE AND FAMILY THERAPIST AND MENTAL HEALTH COUNSELORS

CMS will implement marriage and family therapist and mental health counselor provider types on January 1, 2024. You must enroll in Medicare to submit claims and get paid for covered items or services. You can start submitting enrollment applications after the CY 2024 Physician Fee Schedule final rule is on display at the Federal Register, usually around November 1:

- Your effective enrollment date won't be earlier than January 1
